### Superintendent's Report:

Mr. Warcken, Superintendent, reported on out of field endorsement which allows regularly licensed teacher to teacher in an area that is not currently on their license for a period of up to two years, teaching permit, allows a person without a teaching degree but who has either a degree, certificate, license in an area or at 4,000 hours of work experience within a five year period, American Board route to Licensure is an online program (not part of ND ESPB) requires a bachelors degree and applicant pays a fee to American Board and completes program by passing two tests and this may make the individual eligible to receive a ND teaching license from ESPB, taxable valuation increased, public budget hearing will be Wednesday, September 9th at 6:00 pm before the regular school board meeting, relief valve issue in the kitchen, available leave to staff, professional development days for staff will begin, first day school Wednesday, August 26th, crosswalk lights will be going up on Highway 11, ordered disposable masks, disinfecting spray and sanitizer, transportation is in place, DRN Readitech virtual learning academy, laptops have arrived, smart boards have arrived, Covid-19 preparation, transportation team meeting, online learning planning will be ready for approval next week and have additional professional development days for staff.

Mrs. Olson, Elementary Principal, reported they are preparing for distance learning and the start of school with staff and the traffic flow.

Mr. Warcken, Superintendent, reported for Mrs. Roney that schedules for teachers and students have been updated and registration is scheduled for next week to verify or make changes, been working to map out the hours of the day and organize classrooms/school spaces to maintain physical distancing for all students/teachers, still working out details for larger electives, lunch, locker rooms, hallway congestion, cadet black and technology needs in different areas of school, votech will have 4 students and 15 individuals will be doing ITV classes including dual-credit courses, new science teacher, Alex Askerooth, excited to get started.
